3. You all have been doing a good job concerning registration deadlines.
4. Deborah extended a big, personal "thank you" to all the adults that assisted with 4-H camp this summer.
5. On July 6, the interim county ext. director, Juanita Popenoe, will be meeting with several people concerning the 4-H agent position. The point of the meeting is to "unfreeze" the 4-H agent position with the county (BCC is considering each frozen position on a case-by-case basis) and have it put on an upcoming BCC agenda.
6. Make sure you circle your names on the record book return sheet.
7. Eveland Scholarship money will be available for the 2010 4-H camp. Again, counselors and adults must pay their own expenses and we need to find a way to assist them financially.
